5.APPROVE CONSENT AGENDA:

Council Member Schwartz made a motion, seconded by Council Member Graves approving Consent Agenda Items 5.1 through 5.4. Motion passed on a 5 to 0 vote with Mayor Pro-Tem Ricco abstaining from the vote.

6.1. DISCUSSION AND POSSIBLE ACTION TO APPROVE THE FIRST READING OF ORDINANCE 24-01 AMENDING SECTION 15-2 AND 15-14 REGARDING THE DEFINITION OF HARDSHIP AND ADDING SECTIONS 15-2, 15-5(Q), 15-6(F), 15-11.1, 15-11.2 AND 15-14. (SCHWARTZ)

Council Member Schwartz made a motion, seconded by Council Member Langston to approve the first reading of Ordinance 24-02 amending section 15-2 and 15-14 regarding the definition of hardship and adding sections 15-2, 15-5(q), 15-6(f), 15-11.1, 15-11.2 and 15-14, include a timeframe for posting political signage from 60 days prior to an election to 10 days post an election, and include a penalty up \$500. Motion passed unanimously.

6.2. DISCUSSION AND POSSIBLE ACTION TO APPROVE A BUDGET AMENDMENT FROM THE GENERAL FUND EXCESS RESERVES IN THE AMOUNT OF \$34,095.00 FOR THE PURCHASE OF A WATCHGUARD SERVER. (O'CARROLL)

Mayor Pro-Tem Ricco made a motion, seconded by Council Member Schwartz to approve a budget amendment from the General Fund Excess Reserves in the amount of \$34,095.00 for the purchase of a WatchGuard Server. Motion passed unanimously.

6.3. DISCUSSION AND ACTION TO APPROVE RANKING, SUBMISSION, AND LETTERS OF SUPPORT FOR THE COASTAL MANAGEMENT PROGRAM (CMP)'S CYCLE 30 PROPOSALS. (BOBURKA)

Council Member Graves made a motion, seconded by Council Member Schwartz to approve ranking, submission, and letters of support for the Coastal Management Program (CMP)'s Cycle 30 proposals. Motion passed unanimously.

6.4. DISCUSSION AND ACTION TO TERMINATE THE CONTRACT WITH HANSON PROFESSIONAL SERVICES INC. FOR ALL SERVICES RELATED TO THE WIND AND WATER SPORTS VENUE. (RICCO AND BOBURKA)

Mayor Pro-Tem Ricco made a motion, seconded by Council Member Schwartz to approve to terminate the contract with Hanson Professional Services Inc. for all services related to the Wind and Water Sports Venue. Motion passed unanimously.

6.5. DISCUSSION AND ACTION TO APPROVE THE DRAFT OF CHAPTER 9 OF THE CITY OF SOUTH PADRE ISLAND CODE OF ORDINANCES AS RECOMMENDED BY THE ADHOC COMMITTEE. (CITY COUNCIL)

Council Member Schwartz made a motion, seconded by Mayor Pro-Tem Ricco to approve the draft of Chapter 9 of the City Of South Padre Island Code Of Ordinances as recommended by the Adhoc Committee and include the definition of junk trailers. Motion passed unanimously.

6.6. DISCUSSION AND POSSIBLE ACTION TO APPROVE THE SPI HOLIDAY SANDCASTLE VILLAGE SPECIAL EVENT PERMIT FOR 1 YEAR. (HUFFMAN)

Council Member Schwartz made a motion, seconded by Council Member Graves to approve the SPI Holiday Sandcastle Village special event permit for 1 year. Motion passed on a 5 to 0 vote with Mayor Pro-Tem Ricco abstaining from the vote.
