MINUTES OF CITY COUNCIL REGULAR MEETING CITY OF SOUTH PADRE ISLAND

WEDNESDAY, DECEMBER 4, 2024

1.CALL TO ORDER

The City Council Members of the City of South Padre Island, Texas held a Regular City Council Meeting on Wednesday, December 4, 2024 at the Municipal Complex Building, 2nd Floor, 4601 Padre Boulevard, South Padre Island, Texas. 3.INSTALLATION AND ADMINISTRATION OF OATH TO NEWLY ELECTED OFFICIAL:

Municipal Judge Edmond K. Cyganiewicz administered the Oath of Office to re-elected Council Member Joe Ricco. Council Member Ricco took his seat on the dais.

6.REGULAR AGENDA

6.1. DISCUSSION AND POSSIBLE ACTION TO MERGE THE DEVELOPMENT STANDARDS REVIEW TASK FORCE WITH THE PLANNING & ZONING COMMISSION. (MCNULTY)

Council Member Ricco made a motion, seconded by Council Member Medders to merge the Development Standards Review Task Force with the Planning & Zoning Commission and increase the number of committee members to eight, allowing an extra week for any Development Standards Review Task Force members to apply to be on Planning and Zoning, and that appointments would be based upon attendance. Motion passed unanimously.

ORDINANCE NO. 24-10 MERGING THE DESIGN STANDARDS REVIEW TASK FORCE WITH THE PLANNING AND ZONING COMMISSION BY ADDING TWO MEMBERS FROM THE DESIGN STANDARDS REVIEW TASK FORCE TO THE PLANNING AND ZONING COMMISSION, AND ALLOWING FOR CITY COUNCIL MEMBERS, APPOINTED BY THE MAYOR TO SIT ON THE PLANNING AND ZONING COMMISSION IF REGULAR MEMBERS ARE NOT AVAILABLE. (RICCO)

Council Member Ricco made a motion, Council Member Langston made a motion to approve the first reading of Ordinance No. 24-10 merging the Design Standards Review Task Force with the Planning and Zoning Commission by adding one member from the Design Standards Review Task Force to the Planning and Zoning Commission, and allowing City Council Members, appointed by the Mayor to sit on the Planning and Zoning Commission if regular members are not available. Motion passed unanimously.

6.3. DISCUSSION AND POSSIBLE ACTION TO APPROVE THE PROPOSED VENUE TAX PROJECTS BY THE SPECIAL PROJECTS ADHOC COMMITTEE. (SPECIAL PROJECTS ADHOC COMMITTEE CHAIR BAHARAT R. PATEL)
