

# NOTICE OF 2016 TAX YEAR PROPOSED PROPERTY TAX RATE FOR

A tax rate of \$ .305640 per \$100 valuation has been proposed for adoption by the governing body of City of South Padre Island. This rate exceeds the lower of the effective or rollback tax rate, and state law requires that two public hearings be held by the governing body before adopting the proposed tax rate. The governing body of City of South Padre Island proposes to use revenue attributable to the tax rate increase for the purpose of debt service payments for Padre Blvd improvements.

PROPOSED TAX RATE	\$ .305640 per \$100
PRECEDING YEAR'S TAX RATE	\$ .285640 per \$100
EFFECTIVE TAX RATE	\$ .280893 per \$100
ROLLBACK TAX RATE	\$ .322063 per \$100

The effective tax rate is the total tax rate needed to raise the same amount of property tax revenue for City of South Padre Island from the same properties in both the 2015 tax year and the 2016 tax year.

The rollback tax rate is the highest tax rate that City of South Padre Island may adopt before voters are entitled to petition for an election to limit the rate that may be approved to the rollback rate.

**YOUR TAXES OWED UNDER ANY OF THE ABOVE RATES CAN BE CALCULATED AS FOLLOWS:**

$$\text{property tax amount} = (\text{rate}) \times (\text{taxable value of your property}) / 100$$
